



Opus achieved the Top Guns 5-Star Status from PSN for the period ended December 31, 2016 within the Intermediate Maturity universe¹ for its Intermediate Broad Market Composite. The PSN universes were created using the information collected through the PSN investment manager questionnaire and use only gross of fee returns. Mutual fund and commingled fund products are not included in the universe. PSN Top Guns investment managers must claim that they are GIPS compliant. Products must have an R-Squared of 0.80 or greater relative to the style benchmark for the recent five year period. Moreover, products must have returns greater than the style benchmark for the three latest three-year rolling periods. After that they select only the products which standard deviation for the five year period is equal or less than the median standard deviation for the peer group. The top ten returns for the latest three-year period then become Top Guns 5-Star.



At this point, the top ten performers for the latest 10 year period ending December 31, 2016 become the PSN Top Guns Manager of the Decade.
